2. OBJECTS OF THE TRUST :


- a. To establish schools following the State, ICSE, CBSE or any other syllabus, depending on the need of the people in the locality and as decided by the board of trustees from time to time.

- i. To conduct seminars, symposiums and conferences or summer camps on various subjects of interest in the field of science and technology and humanitarian sciences.






- t. To enter into and carry out arrangements for joint working, or for amalgamation with any other association, society, or institution having objects within the objects of the trust.

 - x. To carry out the objects of the trust in conformity with section 2(15), 11, 12, 13 and section 80G of the Income Tax Act, 1961.

3. TRUST FUNDS AND PROPERTY

- a. A sum of Rs. 9,000/- (Rupees Nine Thousand only) has been pooled as the Trust Fund and nucleus to carry out the main objectives of the Trust.
- b. The FOUNDER OR MANAGING TRUSTEE is fully empowered to receive the funds, contributions, donations, offerings in cash/cheque/online payments or kind and is further empowered to use the same for the upliftment of the main objectives of the Trust.

4. BOARD/COUNCIL OF TRUSTEES

- a. The board/council of trustees shall constitute the Managing Trustee as appointed herein for the purposes of conducting, finalizing all matters and to pass necessary resolutions as is required from time to time for the smooth functioning of the objectives of the Trust and its activities.
- b. The FOUNDER Sri GOPINATH.S shall be the Managing Trustee of the Trust for his life time and thereafter his legatee under the Registered will shall occupy his

- h. The quorum of the meeting shall be one Trustee along with the Managing committee who are responsible to pass such resolutions and to finalize the activities of the Trust. Board of Trustees shall appoint such professionals as required for advice.







5. CONSTITUTION AND MANAGEMENT OF THE TRUST


- The Trust shall be governed and managed by the board/Council of Trustees.

The successor Managing Trustee shall also be the Managing Trustee of the Trust for life and shall likewise be entitled to nominate his successor.

6. POWERS OF THE TRUSTEES

- To administer, supervise and manage the Trust and all its affairs, activities, properties and institutions.
- To constitute such Committees, Managing Committees or Governing Councils for carrying on any of the activities of the trust and entrust to these committees/councils such powers as may be decided by the council of Trustees from time to time.
- The board of Trustees shall open an Bank account in any of the Nationalized banks and such Bank Account shall be operated by the Managing Trustee under this deed, individually.
- To receive contributions, donations, gifts and any other funds given, contributed or donated by individual bodies, trust, associations, parents, students or public at large.
- To receive properties movable or immovable acquired by the trust by transfer taking over, purchase, gift, donations or lease.





7. POWERS OF THE MANAGING TRUSTEE:

- a. The managing Trustee shall be in charge of the day to day affairs of the Trust.

- f. To open and operate an account in any nationalized bank as he may choose in the name and on behalf of the Trust and sign cheque/s and such others negotiable instruments.
- g. To sign and execute all kinds of papers, deeds, documents and to enter in to contacts on behalf of the Trust.
- h. To receive cash and pay cash and enter in to such transactions as the trustees may resolve for an on behalf of the Trust.

DISSOLUTION:


